A durable power of attorney for healthcare (DPAHC) is a type of written legal document called a medical advance directive. It allows another person to make healthcare decisions on your behalf. This person is called a

healthcare agent.

Durable Power of Attorney for Healthcare Decisions - What ...

Medical powers of attorney (sometimes called a health care power of attorney, advance directive, or health care proxy depending on your state) permit an agent to make a principal's health care decisions in the event that they are unable. This is usually a situation where the principal has discussed their wishes with the agent and writes specifics into the form, whereby the agent will see to it that the principal's wishes are carried out if the time comes to act.

Durable vs. Medical Power of Attorney (And Why You Need ...

A durable power of attorney is a legal

document that appoints an individual ('the agent' or 'attorney-in-fact'). While there are specific types of powers of attorney, the specific type that works in relation with a health care proxy is a medical power of attorney.
