For tax year 2019, the 28% tax rate applies to taxpayers with taxable incomes above USD 194,800 (USD 97,400 for married individuals filing separately). For tax year 2020, the 28% tax rate applies to taxpayers with taxable incomes above USD 197,900 (USD 98,950 for married individuals filing separately).

The federal income tax data demonstrates that the U.S. individual income tax continues to be very progressive. See more about the US progressive tax system. The top 1 percent of taxpayers pay a 26.8 percent average individual income tax rate, which is more than six times higher than taxpayers in the bottom 50 percent (4.0 percent).

Summary of the Latest Federal Income Tax Data, 2020 Update

Federal income tax rates for individuals As of 2010, 68.8% of federal individual tax receipts including payroll taxes, were paid by the top 20% of taxpayers by income group - which earned 50% of all household income. The top 1%, which took home 19.3% paid 24.2% whereas the bottom 20% paid 0.4% due to deductions and the earned income tax credit.

In 2020, the income limits for all tax brackets and all filers will be adjusted for inflation and will be as follows (Table 1). The top marginal income tax rate of 37 percent will hit taxpayers with taxable income of \$518,400 and higher for single filers and \$622,050 and higher for married couples filing jointly.
