Once the Board of Directors has approved the dissolution resolution, shareholders vote for or against the resolution. In most cases, a simple majority vote is sufficient to pass the resolution for corporate dissolution.

This can be accomplished with Articles of Dissolution and/or a Notice of Intent to Dissolve. Some states also require that you notify creditors and notify the public of your dissolution. Even if

your state statutes do not require it, it is a good idea to notify creditors and debtors of your imminent dissolution.

The Internal Revenue Code requires that a corporation, within 30 days after the adoption of a "resolution or plan for the dissolution of the corporation or for the liquidation of the whole or any part of its capital stock, make a return setting forth the terms of such resolution or plan and such other information as the Secretary [of the Treasury] shall by forms or regulations prescribe."

Certificate of Election to Wind Up and Dissolve If all outstanding shares of your corporation vote to dissolve, you do not need to file a Certificate of Election to Wind Up and Dissolve with the Secretary of State ("SOS"). However, if the vote for dissolution is less than unanimous, you do need to file the certificate with the SOS.
