Handling Benevolence Gifts According to IRS Guidelines

The Internal Revenue Code requires all benevolence payments provided to employees be taxed. The church must add the amount of the benevolent payments to the employee's Form W-2, and if nonclergy, withhold all payroll taxes like the payment was wages. It makes no difference if the payment is direct or indirect, like to the employee's doctor.

The benevolence ministry should help church members and others alike. The IRS does not allow

churches to help only individuals in a defined group like church members only. The indefinite charitable class must be "hard" to count. The church can restrict their financial assistance to a community, county, or state.
