The New Law of War

IHL is often termed as the law of war, the laws and customs of war or the law of armed conflict, is a legal framework valid to situations of armed conflict, (armed conflicts may be international or non-international in character). It is comprised of the Geneva Conventions and the Hague Conventions, as well as subsequent treaties, case law, and customary international law.

International Humanitarian Law Concepts and Challenges

Each essay examines a particular issue in either the jus ad bellum (the law governing resort to force) or jus in bello

(international humanitarian law) that has proven contentious in terms of applying extant norms to the evolving face of armed conflict. Among the topics addressed are counter-terrorism, cyber operations, asymmetrical warfare, assassination, environmental warfare and the participation of civilians in hostilities.
