NAIC Producer Model adopted in 2000 by NAIC and enacted in Pennsylvania in June 2003 totally modernized licensing for insurance producers. The act in Pennsylvania, Act 147 of 2002, eliminated the two license system for insurance producers, formerly agents or brokers. Adopted in 2005 and enacted in Pennsylvania effective September 30, 2012, will eliminate the two license system for public adjusters, making the adjuster solicitor, an adjuster.
