Plessy v. Ferguson, 163 U.S. 537 (1896) In Plessy v.Ferguson the

Supreme Court held that the state of Louisiana did not violate the Fourteenth Amendment by establishing and enforcing a policy of racial segregation in its railway system. Justice John Marshall Harlan wrote a memorable dissent to that decision, parts of which are quoted today by both sides of the affirmative action controversy.

 Be it dissent or a dissenting opinion, it is written or expressed by judges on expressing their disagreement in a certain legal case where the majority opinion of court leads to the final judgment. Also, this opinion cannot be referred to as a Legal Decision but a minority Report. An explicit disagreement by one or more judges with the decision of the majority on a case before them is called Dissenting Judgement.

Therefore, the concurring opinion joined by the greatest number of judges is referred to as the plurality opinion. A

dissenting opinion (or dissent) is an opinion written by one or more judges expressing disagreement with the majority opinion. A
