Both total household property debt and total household financial debt have been increasing in real terms

(after adjusting for inflation) since the period July 2012 to June 2014, as shown in Figure 1. Overall, total household debt increased by 4% (£45 billion) between April 2014 to March 2016 and April 2016 to March 2018.

- In 2019, UK Households collectively owe £1.6 trillion, which is 13% higher than at the time of the 2008 Global Financial Crisis, paying an estimated £50 billion per year, or £137 million per day, in interest payments.
