FATCA is a double edged sword. Most people familiar with the term will think of FATCA as something that banks and financial institutions have to worry about but in practice both individuals and financial institutions are impacted. The generally stated aim of FATCA is to force foreign financial institutions (FFIs) to report to the IRS where US individuals beneficially own US assets via non-US accounts.

FATCA for individuals | Deloitte UK
Under FATCA, certain U.S. taxpayers holding financial assets outside the United States must report those assets to the IRS generally using Form 8938, Statement of Specified Foreign Financial Assets. The aggregate value of these assets must exceed \$50,000 to be reportable, in general, but in some cases, the threshold may be higher .
