These laws were all abolished when the Communist Party of China established the People's Republic of China in 1949. There was very little Tort Law legislation between 1949 and 1978. During the first decades of Communist Party rule they did not enact new Tort Law legislation, but instead compiled some civil law textbooks based on legal theories borrowed from the Soviet Union. In 1978 the government began some economic and legal reforms that included tort law legislation.
