Introduction. During its annual meeting in 2009, the Executive Committee (EC) of CIOMS considered the desirability of a revision of the CIOMS International Ethical Guidelines for Biomedical Research Involving Human Subjects. The last revision of that document dated from 2002 and since then several developments had taken place, both in the field of biomedical research itself

and in the field of research ethics.

Revision process - CIOMS

The outcome of the CIOMS/WHO undertaking was, in 1982, Proposed International Ethical Guidelines for Biomedical Research Involving Human Subjects. The purpose of the Guidelines was to indicate how the fundamental ethical principles that guide the conduct of biomedical research involving human subjects, as set forth in the World Medical Association's Declaration of Helsinki, could be applied effectively, particularly in developing countries, taking into account culture, socioeconomic circumstances, national laws, and executive and administrative arrangements.

The ERC reviews all research projects involving human participants supported either financially or technically by WHO. The ERC is guided in its work by the World Medical Association Declaration of Helsinki (1964), last updated in 2013, as well as the International Ethical Guidelines for Biomedical Research Involving Human Subjects (CIOMS 2016).

Ensuring ethical standards and procedures for research ...

The CIOMS guidelines have been developed and revised with the problems of conducting medical research in less developed countries particularly in mind. The proposed guidelines were first published in 1982, revised in 1993, and have now been published

in a third version after a revision process lasting three years.
