Rape kits: testing.

(a) Within 60 days of receiving an unrestricted sexual assault examination kit, a law enforcement agency shall submit the kit for testing to a forensic laboratory. The testing laboratory shall return unrestricted sexual assault examination kits to the submitting agency for storage after testing is complete.

Aside from the "Sexual Assault Survivors Bill of Rights," SB 569 also mandated law enforcement agencies retain evidentiary kits for 30 years that have not yet been adjudicated. And except in the cases of minors, unreported kits should be maintained for at least five years.
