The father will only have these rights automatically if he was married to the mother at conception, on the birth of the child, or after the birth.

A parental rights and responsibilities agreement between a mother and a father is only valid if the mother has parental responsibilities and rights. If she doesn't, such as if a child has been adopted, the agreement will not be valid. You can also apply to a court for an order granting parental responsibilities and rights if you're a father.

A child's father has parental rights and responsibilities if (1) married to the mother at the time of conception or subsequently; (2) is registered as the child's father on the child's birth certificate (note: this relates to registration of births in Scotland, in England and in Northern Ireland and not necessarily in relation to a child born abroad).
