Joint Tenancy - An Affidavit of Death allows a surviving joint tenant to notify the title company and/or state of their husband's or wife's death and that title to property that the couple held in joint tenancy should be changed to reflect that the surviving spouse is now the sole owner of that property.

deceased, the survivor may file an Affidavit of Death of Joint Tenant. It may be advisable to consult an attorney due to the legal aspects involving a change in ownership of real property. The above forms can be purchased at most office supply or stationery stores.

### **Affidavit of Death of Joint Tenant/Trustee**

When the tenant you share the property with dies, you can prepare an affidavit of death of the decedent and your affidavit on the joint property and take it to the recorder's office where the property is located. An affidavit of death can also be used to take the tenant's name from the bank account of the property you share it with.
