In Switzerland, Value-Added Tax ("VAT") is levied at a standard rate of 7.7%. A reduced rate of 2.5% applies to some goods such as medicine, newspapers, books and food. Some cantons have additional criteria in their tax laws that require an ordinary tax assessment of foreign residents in Switzerland (e.g., owning real estate). An annual tax return is also due if you freelance or work for a foreign company. In Switzerland, the tax year corresponds to the calendar year. Thus the tax year-end is 31 December.

Residents in Switzerland are subject to unlimited tax liability (that is, they are subject to tax on their worldwide income). In the absence of a tax treaty, foreign-sourced income is taxed gross of any foreign income
