either a judge or a judge and jury. The judge or the jury is responsible for weighing the evidence and making a ruling. Information conveyed in hearings and trials usually enters the public record.

Merchant accepts the dispute, and the funds are withdrawn from the merchant’s account. Reject. Merchant prepares supporting documentation in response and submits it to merchant card processor. Processor submits the case to the issuer, who either accepts representment, or files a pre-arbitration.
