They include many concepts dealing with the nature and mighty acts of Yahweh; sin, punishment and forgiveness; Yahweh's work over and through nations; personal and corporate matters like trust and lament; and Yahweh’s work in nature.

African Americans and the Bible

It is about a particular sociocultural formation but also about the dynamics that obtain in the interrelation between any group of people and sacred texts in general. Thus African Americans and the Bible provides an exemplum of sociocultural formation and a critical lens through which the process of sociocultural formation can be viewed.

In that sense, Kimuhu provides an example of how to contextualize or integrate African traditions into the study of biblical Hebrew, and he also offers insights into the current debate on the study of kinship from the point of view of social/cultural anthropology and the Hebrew Bible legal system. Teachers, students, and researchers in biblical studies, ancient Near Eastern studies, African traditions, and social/cultural anthropology will find this book helpful in their quest to understand family laws, prohibitions, and taboos.

T&T Clark Handbook of Asian American Biblical Hermeneutics *Bloomsbury Publishing*

The first reference resource on how Asian Americans are currently reading and interpreting the Bible, this volume also serves a valuable role in both developing and disseminating what can be termed as Asian American biblical hermeneutics. The volume works from the important background that Asian Americans are the fastest growing ethnic/racial minority population in the USA, and that 42% of this group identifies as Christian. This provides a useful starting point from which to examine what may be distinctive about Asian American approaches to the Bible. Part 1 of the Handbook describes six major ethnic groups that make up 85% of Asian population (by country of origin: China, Philippines, Indian Subcontinent, Vietnam, Korea, Japan) and outlines the specific concerns each group has when its members read the Bible. Taken together the Handbook interprets the Bible both with and for the Asian American communities.

With the debacle of a failing South Vietnamese invasion of Northern Laos as background, A Shepherd to Fools tells the harrowing tale of a covert Hachet Team of US soldiers and Montagnard mercenaries. An earlier attempt to capture them failed disastrously, the facts of it buried. Captain Hugh Englander commands the Hachet Team. The conflict between him and Captain David Weisman, the artillery officer assigned to the mission for artillery support, threatens to tear the team apart. Deep in the Laotian jungle, the team is caught in a final, horrific battle facing an enemy armed with Sarin nerve gas, the "worst of the worst" of the war's clandestine weapons.

Select Papers on the Hebrew Bible *Penn State Press*

Tryggve N. D. Mettinger, emeritus professor of Hebrew Bible at Lund University, has long been one of the best known and most admired voices in biblical studies. His eight (English-language) books and countless articles, published in a career spanning over four decades, have changed the field in many ways. Mettinger is renowned not as an iconoclast, but as one working within mainstream scholarship who is nevertheless willing to challenge cherished ideas and who takes nothing for granted. For example, in one of his earliest works, *A Farewell to the Servant Songs*—published in its entirety in this volume—Mettinger, with his trademark brevity and articulation, drew attention to the shaky ground on which this consensus idea was built and called fellow scholars to reexamine this notion taken for granted by so many for so long. For Mettinger, the Bible is sacred literature, but in biblical interpretation there are no sacred cows. *Reports from a Scholar's Life: Select Papers on the Hebrew Bible* collects 16 studies (one short monograph, twelve articles, and three reviews), originally published between 1977 and 2008, into one volume, along with a new reflective essay. The papers included provide not only Mettinger's most groundbreaking publications, but also glimpses into several of the areas of study that occupied the author. Mettinger's work ranged far and wide in the Hebrew Bible, and here one finds examples of his contributions to the study of, among other things: • the notions of God, the Gottesbild, in ancient Israel; the theology of "YHWH Sabaoth" in the monarchic period; • the development of the story of David in 1-2 Samuel; • aniconism in ancient Israel; the motif of the "dying and rising god" in the ancient world; • narrative criticism of the book of Job; • the development and structure of Second Isaiah. The entire volume is opened by the titular essay, published for the first time here, "Report from a Scholar's Life." This article was originally delivered as the farewell address upon his retirement from Lund University, and it provides a retrospective on his entire life and career.

Reading Psalm 145 with the Sages

A Compositional Analysis *Langham Monographs*

Traditionally, the Psalms have been read in reference to their

historical context. This publication suggests to read a psalm in its literary context and with reference to the editorial intent of its placement in the Psalter. The author proposes that such reading brings holistic richness in our understanding of the thematic patterns underscored in individual psalms. The study analyzes Psalm 145, a unique Davidic psalm, providing the reader with an in-depth understanding to the purpose of its placement.

Fishing for Jonah (anew)

Various approaches to Biblical interpretation *AFRICAN SUN MeDIA*

Fishing for Jonah (anew) introduces students of theology to a wide range of approaches or ?methods? in biblical interpretation, drawing on the book of Jonah for illustrations. This thoroughly revised version of Fishing for Jonah (Conradie, Jonker, Lawrie & Arendse, 1992) represents both a contraction and an expansion compared to its predecessor.

Prophecy and Power: Jeremiah in Feminist and Postcolonial Perspective *A&C Black*

This volume advances the scholarly discussion of Jeremiah via rigorous feminist and postcolonialist theorizing of texts and interpretive issues in that prophetic book. The essays here, by seasoned scholars of Jeremiah, offer significant traction on the biblical book's construction of the persona of Jeremiah and the subjectivity of Judah as subaltern; analysis of gendered imagery for the speaking subject in Jeremiah and for the Judean social body; exploration of rhetorics of imperialism and resistance; and theological implications of feminist-critical perspectives on YHWH and other deities represented in Jeremiah. Essays here deftly synthesize historical, literary, and ideological-critical insights in service of nuanced inquiry into Jeremiah as complex cultural production. The collection represents the growing edge of recent critical thinking on Jeremiah in the United States, Europe, and elsewhere. It should prove invaluable in shaping the parameters of the continuing scholarly conversation on the Book of Jeremiah.

Reading Prophetic Books

Form, Intertextuality, and Reception in Prophetic and Post-Biblical Literature *Mohr Siebeck*

In this volume, Marvin A. Sweeney builds upon his former work *Form and Intertextuality in Prophetic and Apocalyptic Literature* (FAT 45, 2005). He introduces further studies that take up several key issues, including the reading of prophetic books in their final literary form and the significance of textual versions for this reading. He also observes the intertextual relationships between the prophets and other works of biblical and post-biblical literature, and the reception of the prophetic books. Following an introduction that lays out methodological perspective, it includes the title essay for the volume, *Reading Prophetic Books*, as well as selections of papers devoted to Isaiah, Jeremiah in both its Masoretic and Septuagint forms, Ezekiel, individual books from the Twelve Prophets, and the reading of biblical texts in Qumran, Rabbinic, and Targumic literature.

The Characters of Elijah and Elisha and the Deuteronomic Evaluation of Prophecy

Miracles and Manipulation *Bloomsbury Publishing*

Roy L. Heller looks at the prophets Elijah and Elisha in the books of Kings charting a two-fold characterization that portrays these prophetic figures in both positive and negative lights. In the narratives of Kings Elijah and Elisha often parallel other prophetic

figures from Israel's history: they perform miraculous signs, they speak in the name of God, and they pronounce judgments upon the nation of Israel for its idolatrous worship. There are, however, other stories which have troubled readers and scholars alike: Elijah's cowardly running from the threats of Jezebel, his self-pitying complaint to God that he was the only true Israelite left, and Elisha's cursing a group of little boys who, in turn, are slaughtered by two female bears. Scholars have traditionally ignored or belittled the negative stories of the prophets, seeing them as either late additions to the biblical text or as minor, unimportant stories that can easily be dismissed. Heller, however, argues that the dual characterization of Elijah and Elisha reflects an ambivalent attitude that the narrator of Kings has toward prophecy as a whole, an attitude that is reflected in the book of Deuteronomy itself. This forces readers of the biblical text to pose the question; "how may Israel best know and follow God?" The stories of Elijah and Elisha make the answer clear: the words and lives of the prophets are a possible way for God to reveal how Israel is to live, but those words and lives must always be considered with a degree of suspicion and must always be evaluated in light of the clear and straightforward teaching of Deuteronomy.

Networks and Knowledge in Roget's Thesaurus *Oxford University Press*

In this book Werner Hüllen discusses the influence of Roget's Thesaurus abroad (Germany and the Romance countries) and examines how the Thesaurus prepared the way for the more recent idea of network semantics. He concludes by considering the role of synonymy in language from a perspective of cognitive linguistics.

The Educated Elite in 1 Corinthians

Education and Community Conflict in Graeco-Roman Context *A&C Black*

This book examines the educated elite in 1 Corinthians through the development, and application, of an ancient education model. The research reads Paul's text within the social world of early Christianity and uses social-scientific criticism in reconstructing a model that is appropriate for first-century Corinth. Pauline scholars have used models to reconstruct elite education but this study highlights their oversight in recognising the relevancy of the Greek Gymnasium for education. Topics are examined in 1 Corinthians to demonstrate where the model advances an understanding of Paul's interaction with the elite Corinthian Christians in the context of community conflict. This study demonstrates the important contribution that this ancient education model makes in interpreting 1 Corinthians in a Graeco-Roman context. This is Volume 271 of JSNTS.

Focusing on the early medieval herbal recipes found in the Lingbao Wufuxu (The Preface to the Five Lingbao Talismans of Numinous Treasure), this study analyses Daoist asceticism and ideas regarding the body, health, grain avoidance diets, the Three Worms, and immortality.

Understanding Dan

An Exegetical Study of a Biblical City, Tribe and Ancestor *A&C Black*

This book investigates the Dan/Danite tradition in the Hebrew Bible to determine not only what the Bible tells us about Dan, but also how far traditions about the territory, city, ancestor and tribe may have influenced each other. Bartusch argues that the political and theological interests reflected in the relatively late work of the Deuteronomistic Historian have cast a shadow over some earlier traditions, and that by combining social-science models and newer literary criticism with the more traditional historical-critical methodologies, the original meaning of the traditions of Dan may be recovered and clarified. The conclusion of such a study is that the Hebrew Bible as a whole does not entirely support the negative portrayal of Dan in its later traditions.

Action Research

Models, Methods, and Examples *IAP*

The first three chapters of Action Research: Models, Methods, and Examples covers the history, foundations, and basics of conducting action research projects. Tribals, Empire and God

A Tribal Reading of the Birth of Jesus in Matthew's Gospel *Bloomsbury Publishing*

Tribal biblical interpretation is a developing area of study that is concerned with reading the Bible through the eyes of tribal people. While many studies of reading the Bible from the reader's

social, cultural and historical location have been made in various parts of the world, no thorough study that offers a coherent and substantive methodology for tribal biblical interpretation has been made. This book is the first comprehensive work that offers a description of tribal biblical interpretation and shows its application by making a lucid reading of Matthew's infancy narrative from a tribal reader's perspective. Using reader-response criticism as his primary method, Zhodi Angami brings his tribal context of North East India into conversation with Matthew's account of the birth of Jesus. Since tribal people of North East India see themselves as living under colonial rule, a tribal reader sees Matthew's text as a narrative that actively resists and subverts imperial rule. Likewise, the tribal experience of living at the margins inspires a tribal reader to look at the narrative from the underside, from the perspective of those who are sidelined, ignored, belittled or forgotten. Tribal biblical interpretation presented here follows a process of conversation between tribal worldview and Matthew's narrative. Such a method animates the text for the tribal reader and makes the biblical narrative not only more intelligible to the tribal reader but allows the text to speak directly to the tribal context.

Satan, the Heavenly Adversary of Man

A Narrative Analysis of the Function of Satan in the Book of Revelation *Bloomsbury Publishing*

Cato Gulaker employs narrative criticism to explore where the depiction of Satan found in the Book of Revelation is positioned on the axis of two divergent roles. The literary character of Satan is commonly perceived to gradually evolve from the first divine agents in the Hebrew Bible, representing the darker sides of the divine governing of affairs (Job 1-2; Zech 3; 1 Chr 21:1; Num 22:22, 32), to the full-blown enemy of God of the post-biblical era. However, Gulaker posits that texts referring to Satan in between these two poles are not uniform and diverge considerably. This book argues for a new way of perceiving Satan in Revelation that provides a more probable reading, as it creates less narrative dissonance than the alternative of the ancient combat myth/cosmic conflict between Satan and God. From this reading emerges a subdued Satan more akin to its Hebrew Bible hypotexts and Second Temple Judaism parallels – one that fits seamlessly with the theology, cosmology and the overarching plot of the narrative itself. Gulaker explores the functions of Satan in a text written relatively late compared to the rest of the New Testament, but with strong affinities to the Hebrew Bible, concluding that Satan is characterized more as the leash, rod, and sifting device in the hand of God, than as his enemy.
