One way Texas courts determine the status of an asset is the "inception of title rule," which considers the property's status at the moment it is acquired (regardless of what happens later). The state defines marital (or community) property as all property acquired by either spouse during the marriage, excluding separate property. In fact, all property is presumed to be community property unless it is proven (by a preponderance of the evidence) to be separate.
