Criminal Law. The Penal Code is the primary legislation that consists of 511 sections that encompass the wide range of criminal offences that are punishable in the court of law in Malaysia. Other than the Penal code there are specific legislations like the Dangerous Drugs Act 1952, Firearms (increased Penalties) Act 1971, Essential (Security Cases) Regulations 1975 to govern special areas of the criminal offences with its own arrest, bail and sentencing procedures.
