Written Resolution. A Written Resolution or Electronic Consent shall take effect as if it were an Extraordinary Resolution. This template resolution is proposed by the directors, (this subfolder includes alternative examples

A written resolution is passed by the eligible members of the company indicating their agreement to it on a signed document which indicates the resolution to which they are agreeing. For an ordinary resolution: Over 50% of the eligible members of the company must agree to an ordinary resolution before it can be passed.
